**Meeting of 8/10/11**

- Meeting called to order at 7:50 PM.
- Minutes from the last meeting were read. Motion to accept the minutes made by Clyde Temple, seconded by Rich Franks. Vote taken and passed.
- Afton-
  - Report on July Work Party (P. Theiss and C. Temple)
    - Fixed box spring on queen bed
    - Fed electric feed for back water heater into metal conduit piping, re-hooked up
    - Corked gaps where two replacement A/C units were installed
    - Removed wall molding on remaining room to be tiled
    - Confirmed we are getting TV reception for ABC, CBS, NBC, FOX channels
    - Took new photos of trailer for web site
    - Placed spare electronic igniter for furnace inside furnace unit on top
    - Scraped and re-stained porch header (rest of deck also needs to be done)
    - Picked up a \$75 gift certificate for Steve Holland and gave to him
    - Raked out culver in front yard
  - Steve Holland filled out the state application for road fill for parking lot
  - There is a family of raccoons living under the trailer, need to be trapped
  - Steve Holland tilled, limed and planted deer grasses by end of 2nd week in August.
  - Propane was filled for season at trailer. Re-fill cost \$652, \$142 of that was price increase of fuel. P. Theiss to follow up with supplier since tank gauge indicated 42% full.
  - Rich Franks noted next work party is scheduled for Sept 10/11<sup>th</sup>. Targeted tasks;
    - Seal duct work under kitchen/den
    - Hook up power to shed
    - Stain porch
    - Heat tape on water line from pump house
    - Yard clean up/cut up logs to continue
    - Trap raccoons if possible and release by park
- Club received notification from IRS as to loss of tax exempt status due to non filing. Warning mailing had gone to P. Theiss' former address and not forwarded so never reacted to notice. Renewal of exemption requires a new filing and a \$400 fee. Renewal to be tabled for now.
- Discussed possibly re-running membership ad in NY Outdoor paper. Members in the process of sponsoring a few new members so club decided to pass on running ad at this time.
